**TO APPROVE AGREEMENT REGARDING THE PROVISION OF COUNTYWIDE
ADVANCED LIFE SUPPORT EMERGENCY MEDICAL SERVICES
IN LUCAS COUNTY, OHIO**

The Board of Trustees of Springfield Township, Lucas County, Ohio, met in Regular Session on November 27, 2023, at 7617 Angola Road, Holland, Ohio, with the following members present:

Tom Anderson Jr., Trustee Robert Bethel, Trustee Andrew Glenn, Trustee

Robert Bethel moved the adoption of the following Resolution:

WHEREAS, Springfield Township currently collaborates with the Board of Lucas County Commissioners (the "County") and numerous other local political subdivisions to provide countywide Advanced Life Support ("ALS") Emergency Medical Services ("EMS") throughout Lucas County, Ohio; and

WHEREAS, the Township, the County and these other local political subdivisions have been negotiating to revise and restate the method and manner by which to continue to collaborate in the provision of countywide ALS EMS services through an agreement under which the Township will, *inter alia*, be responsible for providing or causing to be provided ALS EMS services in a designated Response Region according to uniform staffing levels and standards of service and receive from the County an annual payment in an amount and manner as provided in the agreement; and

WHEREAS, *Ohio Revised Code* Sections 9.60 and 505.44 authorize the Board of Trustees to contract with other governmental entities and emergency medical service organizations to provide, furnish, obtain or receive ALS EMS services; and

WHEREAS, the provision of countywide ALS EMS is a matter of public health and safety and the negotiated agreement reasonably can be expected to contribute to the prosperity, safety, and welfare of the people in Springfield Township and Lucas County.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of Springfield Township, Lucas County, Ohio, that:

1. The Agreement Regarding the Provision of Countywide Advanced Life Support Emergency Medical Services in Lucas County, Ohio by and between the Board of Trustees of Springfield Township, Lucas County, Ohio, the Board of Lucas County Commissioners and eleven (11) other named political subdivisions in the form attached hereto as Exhibit A and incorporated herein by reference, hereby is approved.




Andrew Glenn seconded the motion and roll was called on the question of its adoption. Vote was as follows:
