RESOLVED, that there be and is hereby levied on the tax duplicate of said Township the rate of each tax necessary to be levied within and without the ten-mill limitation as set forth on Schedule A and B attached hereto:

RESOLVED, That the Fiscal Officer of this Board be and she is hereby directed to certify a copy of this Resolution to the county Auditor of Said County.




