Chairperson, Tom Anderson Jr. – acknowledged and congratulated Andrew Glenn on his appointment as Township Administrator. Noting Andrew’s lifelong residency in Springfield Township, involvement in the development of Homecoming Park, and experience, including two years in administration, 17 years in zoning administration, service on the zoning board and zoning appeals, and 23 years as a township trustee. It was also noted that he has collaborated closely with fellow trustees and is highly regarded for his knowledge and commitment to the township. We look forward to collaborating with him in his new role.


Trustee, Andrew Glenn – reviewed accomplishments since beginning service on January 1, 2003. Key initiatives included securing the first fire contract with the Village of Holland, leading to additional agreements generating approximately \$1 million in revenue for the fire department; overseeing installation of a new metal roof on the administration building; and completing a new salt barn. Several park improvements were highlighted, including additions at Lincoln Green, Valley Stream, Sawmill Run, and Calgary Park, as well as the new shelter house and the addition of Park Place at Homecoming Park.

Additional achievements included passage of the final JEDZ in Ohio and development of the Door Street JEDD and interchange project. Advocating at the state level for changes to right-of-way abatement laws, ensuring township approval is required, and worked with the county to reduce proposed rain tax impacts. As well as 13 years of service as chairman of the District Advisory Council for the Health Department, improving accountability, budgeting practices, and relationships with member communities.




